  - Essay on your strategic management plan for GIST with a long-term vision (within 5 pages of A4-size paper)
  - A copy of resident registration form (in case of Korean candidates)

  - Application Procedure : Documents should be submitted in person or by registered mail(E-mail applications can not be accepted)

# Disqualification Regulations

☐ Disqualification stated in Article 19 of the GIST Charter

Article 12(Reasons for Disqualification) The following individuals shall not be hired as an executive:

1. A person judged to be incompetent, quasi-incompetent, or judged to be insolvent, and not to be reinstated;
2. A person who was sentenced to imprisonment, and three years have not passed since the completion of imprisonment or the judgement of acquittal;
3. A person who was sentenced to imprisonment, and one years have not passed since the end of the probationary period;
4. A person who was sentenced to imprisonment and is still in the probationary period;
5. A person who was receiving the disposition of disciplinary dismissal and is within two years;
